

# Common Agricultural Policy (CAP) update: October 2014

On 28 October, the Department for Environment, Food & Rural Affairs (Defra) released the latest CAP guidance. The document called 'The new Common Agricultural Policy schemes in England: October 2014 update' can be downloaded from the <u>GOV.UK website</u> and is a follow up to CAP update leaflets published in April and August 2014. Each of the CAP Reform Countdown leaflets is designed to build on the one before it and is intended to be read as part of a series of updates.

The latest document has been posted to all Single Payment Scheme (SPS) and Rural Development Programme for England (RDPE) land-based claimants during November. Another leaflet will be published before the end of 2014 to clarify any issues that remain unresolved.

The latest leaflet includes vital information for new and young farmers, explaining how they could be eligible for new Basic Payment Scheme (BPS) entitlements from the 'national reserve'. Young farmers can also find out whether they are eligible to claim a top-up payment worth up to 25 per cent of the average value of their entitlements.

Most existing SPS customers will qualify for BPS, but some operating certain non-agricultural businesses will not be eligible. The leaflet provides further detail around the 'active farmer' requirements of the scheme and definitions of those who may not be eligible.

The leaflet also includes more information about hedges and how they can be counted as Ecological Focus Areas (EFA). Rules around the width, length, height and location of hedges are all covered.

FAS recently hosted a CAP 2015 update webinar for advisers, in partnership with the Rural Payments Agency (RPA). # Soil management requirements in 2015

Cross compliance will continue in 2015 under the new CAP, but there will be some changes. If you claim the Basic Payment Scheme (BPS) or have a Rural Development Programme land-based agreement, you will have to meet the new cross compliance rules.

There will be new rules for soils that will replace the current GAEC 1 (Soil Protection Review), which is being removed. A new set of national minimum standard rules – which are outcome focused and require no paperwork - will be used instead. These will mean that more emphasis is put on actually farming the land rather than keeping a paper log. They will be:

### GAEC 4 Minimum soil cover

Farmers must protect soil by having a minimum soil cover – except where there is an agronomic justification for not doing so, or where establishing a cover would conflict with requirements under GAEC 5. Information on acceptable agronomic justifications and soil cover will be in the soils guidance available later this year.

#### GAEC 5

#### Minimum land management reflecting site specific conditions to limit erosion

Farmers must put measures in place to limit soil and bankside erosion caused (for example) by:

- cropping practices and cropping structures
- livestock management, including outdoor pigs and poultry, causing overgrazing and poaching
- wind
- vehicles, trailers and machinery.

Where compaction may cause soil erosion, farmers must, where appropriate, cultivate post-harvest land and late harvested crops using primary cultivation methods such as ploughing. Alternative primary cultivation methods will be included in the soils guidance.

A reduction in a farmer's agricultural payments could happen where erosion is over a single area greater than 1 hectare, or along a continuous stretch of more than 20 metres long

and 2 metres wide of a bankside or a watercourse. Examples of appropriate measures to limit soil erosion will be provided in the soils guidance later this year.

## GAEC 6

#### Maintenance of soil organic matter level Farmers must:

- not burn crop stubble, except for plant health reasons. Where burning is needed for plant health reasons, it must comply with the Crop Residues (Burning) Regulations (1993) (Regulations 4 (b) and 5).
- comply with the Heather and Grass Burning Regulations (2007) (Regulations 5(2) and 6(1)(a)).
- comply with the Environmental Impact Assessment Regulations (EIA) (2006) (Regulations 4, 9, 26 and 28) and the Environmental Impact Assessment (Forestry) (England and Wales) Regulations (1999) (Regulations 4(1) and 22). Do not plough, cultivate or intensify speciesrich and semi-natural habitats so as to conserve organic matter and carbon levels in soils.

The full 2015 cross compliance and soils guidance will be published in December 2014. Please note that the current cross compliance rules will apply until 31 December 2014. All claimants are expected to continue to follow the current rules and to keep an up to date Soil Protection Review (SPR), which are still subject to inspection.

## Changes to identification and reporting rules for sheep (and goats) from 2015

If you are a keeper of sheep and goats, you should be aware that there are some important changes to identification and reporting rules that will be in place from 1 January 2015.

#### Identification

From 1 January 2015, lambs being identified with the single slaughter tag must be identified with an electronic identification (EID) slaughter tag only. This change is not retrospective, so lambs identified with a non-EID slaughter tag up to the end of 2014 do not need to be re-tagged.

#### Reporting 'historic flock' moves

From 1 January 2015, you must include individual tag numbers for sheep (or goats) identified before 2010 on the movement document, i.e. including your older sheep that are not EID tagged. This does not apply for moves to slaughter (direct or through a red market), which will continue to be batch reported. You still batch record historic flock animals in your holding register. If these animals will move elsewhere (other than to slaughter) next year, Defra and farming bodies have recommended that you re-tag them with an EID pair of tags.

#### Movements

All movements must comply with the general licence for movement of sheep and goats and be recorded in the holding register (Section 5 for 'off-movements', section 6 for 'on-movements'). They must be reported using the Animal Reporting and Movement Service (ARAMs). This can be done electronically by setting up an account on the website or on paper by completing the ARAMS-1 Movement Document. The ARAMS helpline can be contacted on 0844 573 0137 (open 8.00am to 8.00pm, Monday to Saturday) to assist you in using the system. Why not give it a try?

Make sure the required information is entered accurately on the movement document. This includes the tag numbers for individually identified animals (unless moving to (i) an approved Central Point Recording Centre (CPRC)) or (ii) to a different holding within your farm business where you are still the keeper). Do not assume the receiving premises are a CPRC. For a batch of slaughter animals, enter the total number of animals and it is desirable to enter the mix of flock marks too. For all moves enter the correct location addresses, CPH numbers etc. Please note, for moves on to your holding you must always report the completion of that move yourself (on paper or electronically) within 72 hours, even if the sender has set up that move electronically on ARAMS. The sending keeper cannot do that for you. Not to do so is an offence and Defra cannot, and will not, assume that the move has been completed as planned until you report it.

#### **Annual inventory**


Your sheep and goat annual inventory forms will be sent to you later this month. Please ensure you complete the form and return it by 31 December. You must also include your annual inventory total as at 1 December in your holding register (section 7 if you use the Defra paper register). Also, look out for a leaflet that will be included with your forms to remind of the above-mentioned tagging and recording changes.

#### Holding register

Failure to enter information accurately in your register (tagging, movements and the annual inventory) may result in a reduction in your SPS claim. Your register should be retained for three years after the last animal in it has left the holding and should be available on request to an inspector.

# Nitrate Vulnerable Zone (NVZ) grassland derogation

#### How to apply for 2015

Grassland farmers can apply for a derogation from the 170kg of nitrogen per hectare (N/ha) per year livestock manure limit provided they meet certain criteria. If your application is approved and you meet certain conditions, you will be able to spread up to 250kg of manure N/ha per year from grazing livestock on your farm. Applications can be submitted via Defra's <u>Farming Online system</u>. If you are unable to apply online, telephone applications are being handled by the Environment Agency's helpline on 03708 506 506. All applications must be submitted by 31 December 2014.

Whether you are applying online or by telephone, you will need to have information about your holding to hand. If you have not previously applied for or been granted a derogation, you may find a question and answer document that has been prepared on the subject useful. # Abstraction licence expiry



Abstractors who hold a time limited licence that expires on **31 March 2015** must submit an application to replace it (if they still wish to abstract) before **31 December 2014**. The Environment Agency is accepting applications now and encourages abstractors to apply early.

NVZ grassland farmers granted derogations are required to submit 'Fertiliser Accounts' to the Environment Agency by 30th April of the following calendar year. Farmers granted a derogation for 2014 will need to submit their Fertiliser Accounts by 30th April 2015.

# **Key dates**

15 October	Start of closed period for applying organic manure with a high readily available nitrogen content (for example, slurry, poultry manures or liquid digested sewage sludge) to grassland on soils which are not shallow or sandy. (SMR 4)
31 October	If you hold a summer water abstraction licence (authorising abstraction wholly within the months of April to October), the Environment Agency will make actual abstraction return forms available to you from 31 October. You then have 28 days to send your readings to the Environment Agency. (GAEC 18)
1 November	You can burn heather, rough grass, bracken, gorse or vaccinium on land, other than in upland areas, from this date. (GAEC 10)
30 November	If you have a two part tariff agreement for your water abstraction licence, expect to receive your second part charge after 30 November. (GAEC 18)
